The Joys and Responsibilities of OCOD Membership.

There is no time like summer to remind me how lucky we are to have our Training Center. However, having our own space means we must all contribute to it's upkeep. One member responsibility is to help keep the building clean and in good order. So, this is a refresher on what is expected of each member regarding building upkeep.

- Members will participate in a minimum of two cleaning days per year - one occurring January - June and the second July -December. If you live more than 45 minutes from the TC, you may vacuum, or clean bathrooms, or another assigned job when you are already there for class. If you only do <u>agility</u>, helping to clean and sort agility equipment counts for cleaning. Weekly set up and break down does not.
- 2. When present for cleaning (alone or with the group), each member will sign in on the CLEANING notebook that is on the Table near the front desk. This is the list we will use to determine who has met the cleaning requirement.

It takes a village to care for our building and we need everyone to do their part.

The deadline to get your info and check to her is November 1, 2022. The 4X6 plaques are \$29.70. Please include both the registered and call name. Tags are \$11.15 each. Include the title earned and date earned. Make payment check to: Obedience Club of Daytona. Place check in Vicki's file folder at the OCOD training center or contact her for mailing instructions.

Excerpt from the standing rules:

TITLE AWARDS

A. Upon receiving a dog's title a member may purchase a plaque bearing dog's registered name and call name.

- B. All titles received by same dog may be purchased and will be printed on hanging tags with title and date earned.
- C. All plaques and tags must be submitted to the Trophy Chairperson in writing on or before the closing date (no exceptions), to be determined by the Awards Chairman.
- D. A proof will be sent before ordering to be sure spellings and awards are correct, and must be returned to Chairman with approval.
- E. All plaques and tags must be paid for **[by November 1st deadline]** in advance of order.



OCOD'S DECEMBER TRIAL UPDATE BY RALPH ORLANDO, TRAIL CHAIRMAN

September 25, 2022

Hi All,

In just a little less than 7 weeks our winter Rally/Obedience Trials will be here. The dates are December 9-10-11. Rally only is on Friday 12/09 and beginning with this trial we are using a little different format. The plan is to overlap the two trials with one starting at 8 Am in ring #3 and the second trial starting at 10:30 in ring #1. The early judge will be Norine Noonan who ran Rally Nationals this year. In the later trial in ring #1 the judge is Robert Millar. The idea behind this plan is to shorten the work day for each judge and also to shorten the day for the exhibitors by most likely a couple of hours.

Then on the weekend there will the Novice class judged by Sally Sherman. Sally is new to judging and has for many years competed very successfully with her Goldens at a very high level. Since she is a new judge, she is only approved to judge in Novice and AKC only allows her to judge for two of the 3 Novice trials. Sally is easy to pick out in a crowd. She is the Blond woman holdings 3 leashes attached to 3 Goldens and one is always carrying a treat bag in her mouth. The replacement judge for her on Sunday will be Carolee Boyles.

The other two judges for Open & Utility for both days are Jeff Kern and Nanci Hayes.

Beginning in our July 2023 trials the Sunday will add a second trial in an effort to help the club increase the revenue on these events.

As always, the crating will be at a premium and so we ask for your help in removing your crate (s) if you are not showing. Crating for all 3 days is in ring #4 & #5 as well as the center aisle.

Staffing these trials has changed slightly since covid appeared almost 2 years ago. Prior to covid 4 Stewards were the ring staff. There is a table steward who manages the paperwork for the judge. Then both Novice and Open require a figure 8 heeling pattern but no longer use stewards as figure 8 posts. So, the steward count has been reduced to 3 with two cones replacing the need for 2 people posts.

Along with great judges, a great facility and hospitality from our members, the job of the stewards very often ring high praise from our guests. Starting with the October club meeting there will be a sign up for stewards to volunteer for one or more days at these trials.

GENERAL MEETING

SEPTEMBER 12, 2022

President Michele Lemole welcomed everyone and called the meeting to order at 7:03 pm. The sign in sheet was passed around - 18 members were present. There were no guests at the meeting.

Janet Berry started by saying that anyone can do Fast Cat and she had handouts to give out. It is Lure Coursing. It consists of a hundred yard dash. If you have two people it's good. If you only have one there are always extra people there to help. One person will be on one side of the hundred yards to release the dog and the other person will be down at the other end to catch your dog. Some dogs are superfast when this girl was just a year and a half old she was the fastest in the country. It is a titling event and she is up to F-Cat 3. I haven't done it since last January. I have information on how to figure their time when they run the hundred yards. The timer will stop and they will say your dog ran eight seconds or eight and a half seconds. There is a calculation here that you take your little receipt paper and write it down and you multiply the miles per hour to get your time and you get points for all this. Just say 8 ½ would be an average of 25 points. Each time you run you get another 25 or 50 points. Greyhounds will get about 5 seconds. That dog is made to run. There is a difference for a little dog, medium dog and large dog. They would calculate the numbers differently because of the size of the dog. There are handicaps for the dog sizes when you figure your miles per hour. If you give your dog treats before your dog runs or after your dog runs it will likely through up. Wait till your dog cools off most places will have a little kiddie swimming pool for the dogs. Make sure to give your dog some water and cool your dog down before heading for home. You can use your AKC or pal registration numbers when you run your dog or just do a fun run. When you get there they will have a board posted. You can sign up and find out when you will be running. Janet is looking for volunteers to help at Dog Sports Unlimited when we have our fast cat days scheduled. We need 2 committee members for the weekend that we run. Michele said Saturday Oct 1st is our fun day from 9am to 12pm at Dog Sports Unlimited and more information will be in the newsletter.

Claire said we should have another fun day at Silver Sands when we put all the tunnels out and did Agility and it brought in a lot of money. Michele said the only way we can have an agility trial next January is if we have help. Janet said we would like someone to put an education table when we have the fast cat trial. We'll have to get ahold of Pat Mozden and ask her if she will be able to do it. Michele said our first Fast Cat trial will be Nov. 5th and 6th. Our second Fast Cat trial will be on Dec. 31st. Janet said West Volusia will have their confirmation trial in November and Fast Cat will also be there. Janet wanted us to know that you can always do a fun run in Fast Cat for \$10 in the beginning to make sure your dog likes it. Janet said to make sure you take a copy of the brochure about Fast Cat.

Report of the Secretary: We have three people that have applied for membership. Miriam Clark (S) Lake Helen, Diane Lewis (S) Sanford, and Diane Ryan (S) St. Augustine. There is no correspondence.

Report of the Treasurer: Renee says we need volunteers for the scent trial. Even if you are in the trial you can step up and work the board until it's your turn and someone else can step up and take over the board. They are going to move the ring gating closer into the ring so we could have more room in the isles. She doesn't know how many of us will be affected but I don't want any more than 3 people lined up in the aisle this year because we had trouble last year. We will have 2 people waiting and 3 people lined up and that's it. Renee said we had a \$5700 tax bill coming due.

Since there were no other questions, Michele asked if there was a motion to adjourn.

Shirley motioned to adjourn, Claire seconded.

Meeting adjourned at 7:44 pm.
