
No Dinner This Month



Ralph says he will be needing Stewards for the trial. Kris asked if there was a premium out for the trial yet. Ralph thought it was out already. Anna said we are going to run the match like we did last time. It will be day of entry and no pre-registering. The Match will be on Saturday Dec. 3rd the week before the trial. Kris said Nov. 12-13 we are having a trial put on by the Jacksonville Club. Kris said the other event we have coming up is Fastcat. We lost our free day because of the hurricane and that will have to be rescheduled. We have a Fastcat trial that we will be putting on that is on Nov.5-6. That is at Dog Sports Unlimited which is in New Smyrna Beach. It is an upcoming sport. You take your dog out there and they chaise a bag. It's a lot of fun. We do need a couple of volunteers to represent us there. Contact Janet Berry if you're interested in volunteering. You will get a free run if you volunteer. Kris said you can get titles. Next week in Orlando at the Orlando show we will be having a CDSP Trial. If anyone is interested in coming and entering we will have day of show entries. You would have to be there  $\frac{1}{2}$  hour before the show starts to sign up. The judges are very laid back and CDSP is a lot of fun. It's on both Sat. and Sun. with 2 trials on each day. We hope it is a big success. If you're interested in coming please contact Kris and she will give you the details.



#### OCOD'S DECEMBER TRIAL UPDATE BY RALPH ORLANDO, TRAIL CHAIRMAN

Hi All,

In just a little less than 7 weeks our winter Rally/Obedience Trials will be here. The dates are December 9-10-11. Rally only is on Friday 12/09 and beginning with this trial we are using a little different format. The plan is to overlap the two trials with one starting at 8 Am in ring #3 and the second trial starting at 10:30 in ring #1. The early judge will be Norine Noonan who ran Rally Nationals this year. In the later trial in ring #1 the judge is Robert Millar. The idea behind this plan is to shorten the work day for each judge and also to shorten the day for the exhibitors by most likely a couple of hours.

Then on the weekend there will the Novice class judged by Sally Sherman. Sally is new to judging and has for many years competed very successfully with her Goldens at a very high level. Since she is a new judge, she is only approved to judge in Novice and AKC only allows her to judge for two of the 3 Novice trials. Sally is easy to pick out in a crowd. She is the Blond woman holdings 3 leashes attached to 3 Goldens and one is always carrying a treat bag in her mouth. The replacement judge for her on Sunday will be Carolee Boyles.

The other two judges for Open & Utility for both days are Jeff Kern and Nanci Hayes.

Beginning in our July 2023 trials the Sunday will add a second trial in an effort to help the club increase the revenue on these events.

As always, the crating will be at a premium and so we ask for your help in removing your crate (s) if you are not showing. Crating for all 3 days is in ring #4 & #5 as well as the center aisle.

Staffing these trials has changed slightly since covid appeared almost 2 years ago. Prior to covid 4 Stewards were the ring staff. There is a table steward who manages the paperwork for the judge. Then both Novice and Open require a figure 8 heeling pattern but no longer use stewards as figure 8 posts. So, the steward count has been reduced to 3 with two cones replacing the need for 2 people posts.

Along with great judges, a great facility and hospitality from our members, the job of the stewards very often ring high praise from our guests. Starting with the October club meeting there will be a sign up for stewards to volunteer for one or more days at these trials.
