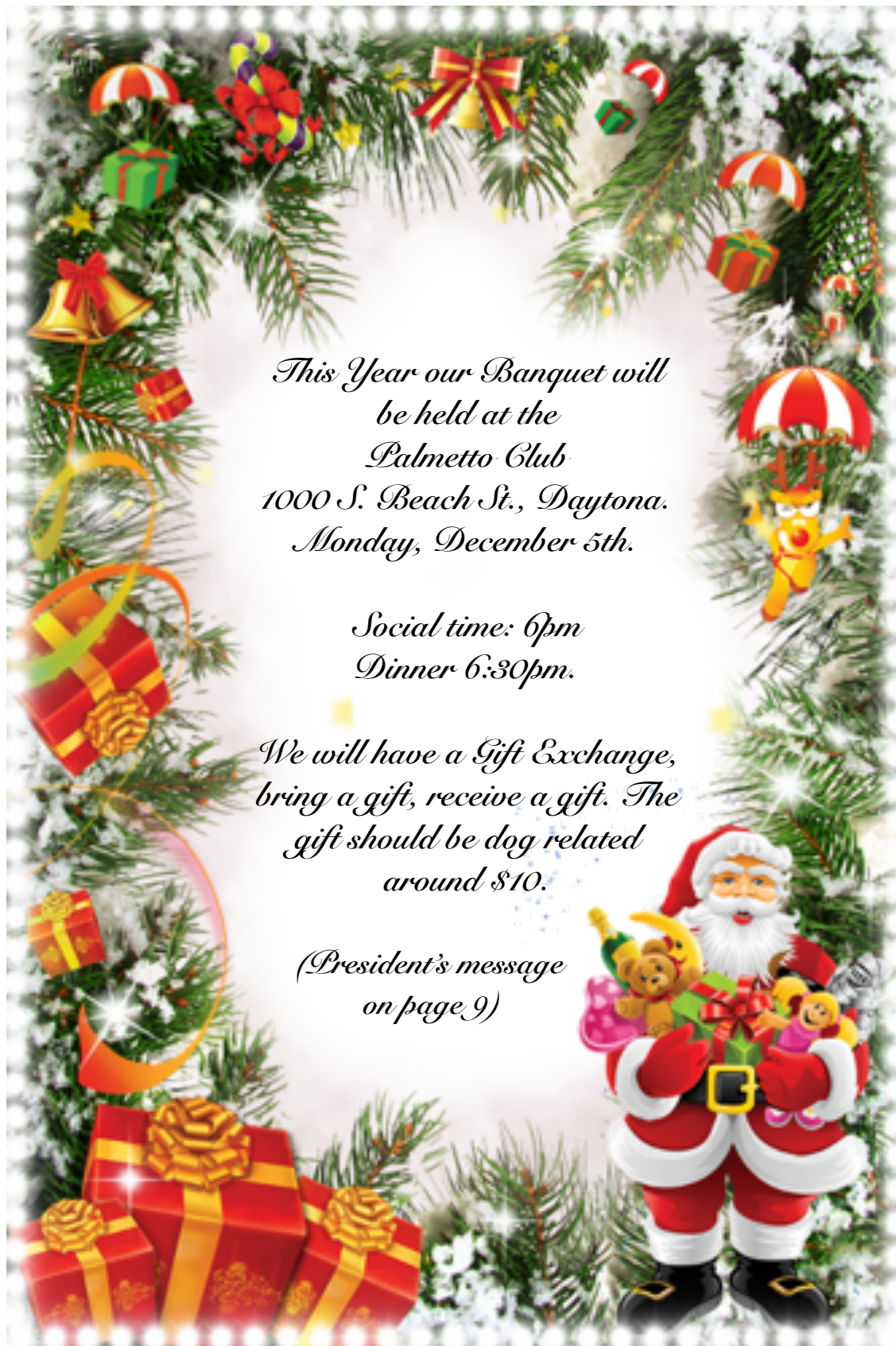

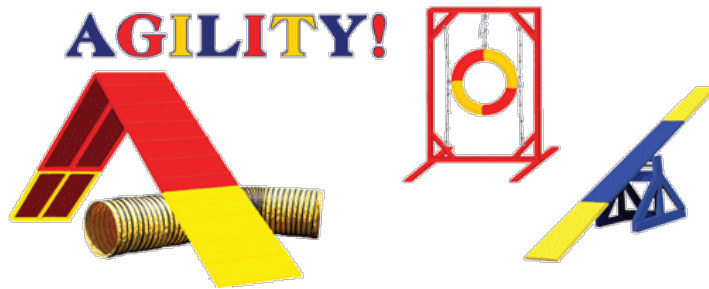
Mark Berber & "Fia" earned her FCAT Title at the OCOD FastCat Trial this weekend.

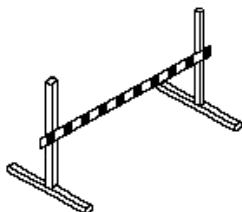

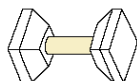
