Obedience Club of Daytona**General Meeting****January 10, 2022**

The Meeting was called to order at 7:04pm by President Michele Lemole.

Michele Lemole started by saying she had been a member of the club for a long time and has also worked in the community as a Registered Nurse in ICU. She said it's wonderful to serve a club that she has been a member of for so long.

Sign in sheet was passed around – 23 members were present. There were no guests.

Wins and Brags were announced. Any new Wins and Brags should be submitted to Joan for the Chatterbarks.

Minutes of the last meeting were not read but were published in the Chatterbarks.

Report of the Secretary: There was one new application for membership: Jeannette Graham (S) NSB. There was no correspondence.

Report of the Treasurer: Renee had to leave early and had said our numbers were off in December because we usually don't have any classes starting in December. We talked about using Quick Books for online payments and accounting to make stuff easier for us and our accountants.

Michele introduced our two guest speakers OCOD members Nina Daly and Kathy Lo who has her certification for Dog Massage. Kathy will be massaging Nina's dog Jelly Bean. To get her certification Kathy in addition to her classes of Biology, Bone and Muscle Structure was required to do 100 complementary Massages on dogs with various problems. Her classes covered dogs with anxiety issues, elder dogs with arthritis, and dogs that had injuries with mobility issues to name a few. Her massages will also de-stress dogs so they will do better at trials. She said the dogs are usually more comfortable at their home in a quiet room. She also uses various essential oils. Her fees are \$35 for a half hour of massage and if you're a club member the rate would be \$25. If you have any questions for Kathy, just give her a call at 386-451-6932.

Report of the Board of Directors: Michele said these are some of the items that were discussed at the Board Meeting. Online applications and payments still need some tweaking otherwise they seem to be doing well. We want to thank Pat and her husband Jim who have been taking care of the building and working like crazy to get everything fixed. Pat is also our representative for the condo association meeting. We are working with the condo association to get some things fixed. Some things we are going to take care of on our own.

Our Agility trial will be January 21st, 22nd and 23rd. We have signed the agreement to hold Fast Cat trials. We are sponsoring the trials. Fast Cat is a 100 yd. dash for your dog. You should do stretches and warm up your dog before running. There will be 2 events each day. You can sign up ahead of time or run on the day when you arrive. It's more money if you run on the day of entry. We are going to start our Agility classes again. Our Basic Manners classes at Port Orange are doing well.

Terrie has been working on a Fund Raising Committee. She gets donations from businesses and the community and makes beautiful baskets to raffle with the proceeds going to the Building Fund. Michele said we are going to get Terrie some help for her committee. If you are interested in helping with that please get in touch with Terrie or me. Her number is on the membership roster. Terrie will have a fund raising basket at the Agility trial and she also volunteered to help work every day of the trial.

The K-9 Training Area on Tiger Bay Rd. is getting ready to pour concrete for the platform which will hold the Volusia County K-9 Memorial GSD statue for dogs that have passed away in the line of duty and also those that had worked for the Sheriff's office that had passed away. Ralph plans to have teams come to demonstrate for the February meeting. Ralph wants them to talk about the project they're doing and also give us a demo. In the past it was terrific. In the past our members were invited to the training facility one afternoon for a training session. It was unforgettable. Ralph is having a Tracking Trial on February 8, 2022. He doesn't know yet how many how many dogs are entered. They discussed the insurance for the trial. How can we train our dogs to do tracking? Are there any seminars? It was suggested that anyone interested in this should join the Tracking Club of Florida. Maybe we can set up a Tracking Seminar. Ralph will ask Robin.

Pat is asking us to not leave personal equipment here unless you put your name on it or it may be rehomed.

Lisa Liguori is the Trial Chair for the upcoming Agility Trial. Her Foundation class is moving to Mondays at 6pm. She said it's a fun class that shows you how to handle your dog and train it how to move safely and prevent injuries. After your dog graduates the foundation class you would have classes at Silver Sands and take Novice Prep with Linda Hudak. Michele and Lisa teach Open, Excellent and Masters Classes. Classes start Wednesday night at 6pm and the advanced class starts at 7pm. You are welcome to come to check it out. These classes have produced multiple MACH Titles in our membership: Coralee Leon, Linda Hudak, Kathy Bennett, and Renee Morrow to name a few. MACH stands for Master Agility Championship. Lisa asked for volunteers for the trial starting on Thursday 1/20 and running through to Sunday 1/23. There were 159 more entries this year than last. The net profit for last year was \$5,900 +. Please come out and volunteer you are really needed. Call Lisa to sign up. Michele asked if we had a motion to adjourn. Lisa was first seconded by Adriana
