

Report of the Treasurer: Renee said we paid out \$1700 in insurance, and \$2000 in A/C repairs. WE will probably pay \$1000 to fix the windows. May was down \$3000 and June was down \$900. We payed Nina for the printer. We took in \$800 for the Scent Work Seminar and \$640 for the match.

Pat said our C-match went well. The folks that attended felt that it was well run and they enjoyed themselves. We have our trial coming up. If you haven't been a steward consider working if someone drops out at the last minute and they need an extra worker. If you find anything that needs to be corrected in the website please notify Pat and she will call Chris. Pat has spoken to Able about our limping parking lot lights. She is working with him to improve the situation. Pat was contacted by the Daytona Beach Commissioner who requested our participation in an event scheduled on a late Tuesday afternoon in August. Since the weather is so hot we will postpone to another time of year.

There have been some Standing Rule changes. They will be posted in the Chatterbarks. OCOD's offering for one dog class (either puppy or Basic manners) will only be for active or retired military. The qualifications will be listed in the Chatterbarks. The Humane Society discount has been eliminated.

Anna suggested we have Temperament testing and CGC on the same day possibly in November or December. Nina said she could help do the temperament test.

Pat said that wraps up what she has and asked if anyone had any comments? Ralph said Maria has set up a display for taking pictures this weekend in the training center. It has a backdrop with American flags. If you bring a camera you can take some pictures back there. Pat wanted to thank everyone for being here. We really appreciate your input. We are adjourned for the evening.


