## **TWO (2) TEMPERAMENT TESTS**

**November 9, 2024 12 PM**

Pre-registration required for each test.

25 entries only, 2 tests each \$30 (\$30 each = \$60)

The AKC Temperament Test, the ATT, is a temperament test designed for all breeds of dogs.

The ATT, a pass-fail noncompetitive test, assesses the reaction of any breed to stimuli in the surrounding world. Dogs are tested in the following six categories:

**Social, Auditory, Visual, Tactile (touch), Proprioceptive (motion) and Unexpected Stimulus.**

All dogs who pass the ATT twice under two different approved ATT Evaluators may earn the AKC Temperament Test title.

The ATT screens for fear, shyness, inability to recover, and lack of cooperation. Desired traits are that the dog will be emotionally stable, cooperative, inquisitive, appropriately social for breed, and biddable.

### **Why take the AKC Temperament Test?**

For purebred dogs, each breed's parent club has a written breed standard that includes information on the breed's temperament. Taking the ATT allows the dog owners to determine how close their individual dog's temperament is to the breed's standard.

For the owners of mixed breed dogs, the ATT may prove insight on the temperament of individual dogs.

The ATT provides information about a dog's reaction to a variety of stimuli. ATT testing can identify behaviors related to temperament that can be addressed thru training.

### **EACH TEST REQUIRES A SEPARATE TEST APPLICATION**

**Dogs must be at least 1 year of age, Registered or enrolled with AKC, and have an AKC, PAL, OR AKC CANINE PARTNERS NUMBER.**

## OCOD'S DECEMBER TRIAL UPDATE BY RALPH ORLANDO, TRIAL CHAIRMAN

Hi All,

Gaining on us are our Rally/Obedience trials beginning with double Rally trials on December 6. Then for the weekend we will have our Saturday and Sunday double trials. Leslye Pinnell is the Rally judge both trials.

Then on the weekend there will be all of the regular classes as well as some non-regular and random rewards classes. The last ring running on Sunday even with the double trials should end by about 2pm or so. On the weekend our judges will again be Leslye Pinnell along with Russell & Bonnie Hornfisher who will switch between Novice/Open & Utility. As always, the crating will be at a premium and so we ask for your help in removing your crate(s) if you are not showing. Crating for all 3 days is in ring #4 & #5 as well as the center aisle. If you are one who needs to remove a crate, you can take it home by Thursday December 8 or simply find a spot to store it neatly near the rear right door area.

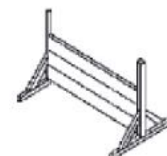
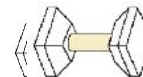
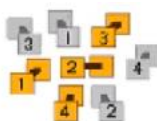
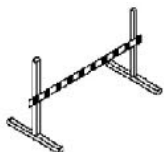
Staffing these trials has changed slightly since covid appeared almost 3 years ago. Prior to covid 4 Stewards were the ring staff standard. There is a table steward who manages the paperwork for the judge. Then both Novice and Open require a figure 8 heeling pattern but no longer use stewards as figure 8 posts. So, the steward count has been reduced to 3 with two cones replacing the need for 2 people posts. So as a bare minimum 3 stewards but if we can get 4 this is a bonus plus.

Along with great judges, great facility and hospitality from our members, the job of the stewards very often ring high praise from our guest and from the judges. On the job training for those wanting to learn is also possible. I also suggest for new stewards to sign up for the match a week earlier or contact Ralph if you can come to a training class to be a practice steward. After all of that said your Judge will brief you before each trial begins.

Starting with the October club meeting there will be a sign up for stewards to volunteer for one or more days at these trials. The premium list for exhibitors is being proofed and will go out soon out for entries.

As per the premium list the host hotel is the Country Inn & Suites by Radisson in Port Orange and if you book a room let them know you are showing at the Obedience Cub of Daytona Dog Trials.

Pat said we are having people order their own awards for 2024. This year we will not be having a central person announcing the awards at the banquet. If they want to come to the dinner we would be happy to have them announce their awards and we will all clap for them.

This weekend we have a scent work trial setting up on Thursday. If you are available on Thursday at 2pm they need help setting up. Your help will be very much appreciated. On Friday, Saturday, and Sunday Terrie still needs stewards for the trial. The Port Orange Library is holding a "How to Festival" this weekend and a small group of us are going to the Festival to show off our dogs and show off some training moves. We want people to see how nice it is to have a trained dog and possibly take our classes. AKC has decided that we need new jumps for obedience trials. The board has voted to allocate \$2,000 to purchase 4 sets of jumps one for each ring. We are still having water leakage in our utility room. Jim and I are trying to figure it out and fix it. Parking lights are in the works. There were a number of things that needed to be worked out with our condo association. Technically we own this unit and the original owner owns the rest of the buildings.

Saturday ring times are going to change from 8am to 12noon. We will probably change our prices for ring time in the new year. There is a new assistance dog group in the area called Duo Assistance Dogs who are bringing some of their dogs to our classes. A trained service dog is eligible for one free puppy class and one free basic class. We welcome them to our classes and we are glad to have them here. Linda Hudak said if you talk to anyone in that group tell them that they have to go through their organization about taking our classes. We'll also need a letter from their organization. They will then go through the same application process online. Linda said there will be something written up about ring time and it will be posted in the newsletter.

Adria said at our October meeting she will bring her little Darla with her and will be speaking about therapy calls, what makes a good therapy dog and how to get an AKC title. She also mentioned AKC registration groups and different awards AKC gives you as you pass each milestone.

Joan Costello is going to be the chair of the nominating committee this year. It's that time this year when we start asking people about serving on the board again. We need to have new people and new ideas. We look for people that have some experience with the club and that is also helpful. Joan will be contacting some of you to serve on the committee and then I assume we will have some slots to fill. Is there any type of speaker that you would like to speak before the group? Anna would like to hear about sports that other members are involved in like scent work, barn hunt, fast cat, and dock diving. Terrie suggested having Nina talk about dog CPR and dog first aide. She will probably have a seminar and have a small charge for it on a Friday afternoon. Confirmation classes will be starting the first of the month in October. Pat asked if there was any more business or announcements that need to come before the group. Pat said we had a good meeting and thanked everyone for coming.
