I hope you and your canines will have a good start to 2025 and we'll be seeing you soon.



<u>Diane and "Flair"</u> earned their First UDX leg at the Daytona Trials, scoring a 197 in Open and placing fourth behind some top competitors - plus a 194 in Utility.


### UNBELIEVABLE. GREAT JOB !!


# Alan Wilcox
