

This seminar will cover a new approach to training the individual exercises required in an obedience class in a manner that helps the dog and handler better prepare for the trial experience. Highlights of this method include:

- learning how to maintain the pieces of exercises that the dog is already performing correctly
 - learning how to work on problem areas and/or respond to errors without making the exercise "hot"
 - rehearsing in a way that is interesting and fun for the dog
 - duplicating the focus needed from the handler to trial successfully (even if training at home)
- making sequencing a regular part of the dog and handler's training so that trialing feels more familiar

Report of the Secretary: We have two new members. Brenda Gavin Port Orange (S) and Kathy Arnold Ormond Beach (S). There was no correspondence.


Next we had the Gift exchange headed up by Nina Daly who makes it so much fun every year. There were lots of great gifts chosen from the decorated wrapped packages.
