President's Message,

Congratulations again on working to achieve our goal of paying off the Training Center. As newly mortgage free property owners, we continue to have responsibilities. So, I'm going to use this month's letter for some reminders.

We appear to have eliminated mice from the building thanks to your cooperation. To prevent reinfestation, don't keep any human or dog treats (including bones and chews) in crates, tables, or anywhere in the building. Even wrappers need to go outside.

There is a checklist posted under the thermostat and near the front door that tells us things to check before the last person leaves the building – especially in the evening. Please refer to this before leaving. Perhaps the most important item on the list is to check ALL DOORS to be sure they are locked. It doesn't matter that you didn't use it, your class didn't use it, or you didn't see anyone use it. EVERY door needs to be checked, including both front doors. It only takes a moment.

No one should exit the building alone in the evening. The last two or three people leaving should go together to the cars and not leave the parking lot until every car has started. Normally instructors have an assistant who stays with them but if you find yourself without one, ask a class member to stay with you.

We're now in the second half of the year and it's time to both clean and help with a club activity before December 31st. Cleaning and assisting now will allow you to continue to receive club discounts January 1 – June 30th in 2026.

Finally, remember to treat each other and visitors with kindness and respect. We live in a world that is increasingly angry and cruel. Let's keep our training center a pleasant and friendly place to train your dog. Do your best to arrive with a positive attitude and help create a positive environment.



The file cabinet in the the desk has names of instructors assistants and some members for mail.







It's thrilling that we've been able to do all this equip this building, have trials in this building, lease it out for weekends for other groups to have trials in this building, and we've paid it off. Now it's our spot and that thanks to all of you. Renee was just talking about we do that by raising money with the classes and the other events that we hold. Somethings raise more money than others. It's the combination of everything that brings in money. The whole club needs to be thanked for doing this and Renee has brought in a cake to celebrate. Renee found the building and talked to the owner. It was a thrift store at the time. Ralph, his cousin, and other people did a lot of painting in here and tons of cleaning up. It was pretty rough when we move in and a few years later we put in the mats. As training facilities go we have a lot to be proud of. Joan said three years ago a judge at one of our trials said to her that we had the largest training facility along the east coast in the United States. Everyone is so thankful to Hoke Johnson who helped us save money and spend it wisely so that our club would thrive, grow, and enable our members to help others.
