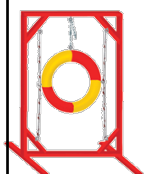

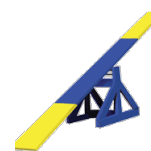

OCOD'S Agility Trial Coming Soon! January 16,17,18 At Silver Sands Bridal Club

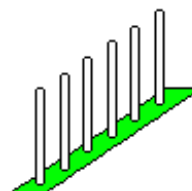

From Ralph Orlando about our Obedience & Rally Trials

To Trial stewards, judges, clean up crew but 2 names not on our Roster list so also please send out to club to let all workers know how much they are appreciated..

For most of our 3 day event the steward sign up was at absolute minimum of 3 per ring (1 table and 2 ring workers) and gate in just a few.

Many of these workers were brand new to the classes that we were running. But even so I can not brag enough on how well everyone performed. The new panel jump is a challenge that was quickly mastered in both the open & utility rings. Most of the stewards are not at the open/utility levels meaning they have very little if any experience setting up the 3 jumps in these 2 rings. All I can say is that you all are very quick learners and in most cases both rings ran very smoothly.

I have included all 4 judges in this email because I also want them to know how much we all (event staff and club members), appreciate their knowledge and efficiency in running these events.

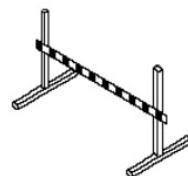
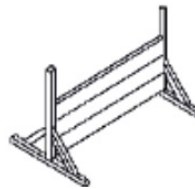
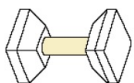
